

## Traffic Accident Claim Compensation

The traffic accident claim is a procedure that can be conducted when you've been involved in a traffic accident that wasn't your fault. Either you are a car driver, a motorcycle driver, a truck driver or a pedestrian, it doesn't really matter. The traffic accident claim can reward you with the compensation you rightfully deserve.

The traffic accident claim is actually a very generic term. It can also be referred to as road accident claim, because they are one and the same thing. Its purpose is to help the claimer get compensated for injuries or other type of losses he/she might have sustained after an accident. The claim can be coordinated by a solicitor (a lawyer), who is specialized in this sort of situations. The process usually takes a few months' time to be resolved, but there are also situations in which it can be done quicker, when the accident is minor and has no serious repercussions.

Usually, people tend to get just their insurance compensation, without knowing how much they lose. There's a psychological tendency to avoid all things related to lawyers and lawsuits, and this prejudice could only do you harm. That's because the insurance company will try to solve your compensation claim in their best advantage. Yes, you guessed it, they will try to minimize your compensation much as possible. If so, you may be missing out. Because the help of a lawyer can get you much further.

If you are scared at the prospect of going to Court, don't be. Usually these cases are solved without the need to go to Court. Only serious cases involving death of a relative or cases in which someone suffers very severe injuries are taken to Court. That's because those cases involve a lot of money.

Anyway, let's get back to business. So, you suffered a traffic accident. You want to make a traffic accident claim. You feel that the compensation your insurance company has proposed you doesn't do you justice at all. So, it's time to call a lawyer. First of all, ask all your friends and relatives if they know a very good one. They might have gone through something similar and they can help you. If not, there are a bunch of good companies online which you can contact or one even in your neighborhood.

When you call the attorney, he will ask you for an interview. These lawyers usually work on a no win no fee basis. This means that they get their commission for representing you only when and if they win the case. That's a relatively new type of procedure, and it has many advantages. However, make sure that you have some money in your bank account, for reasons I won't discuss here. At the interview, the lawyer will ask you everything about the accident. Answer honestly, because you don't want to sabotage your only ally in this process. After a brief evaluation, he will give an estimate of the amount of compensation he can get you. When you compare this to what the insurance company offered you, you'll see a great difference. When he is ready to take your case, the claiming process begins.

Your attorney will try to collect as many pieces of evidence as he can. If you managed to gather some yourself from the accident, that's great. You will have to go to periodical medical examinations. That's not only for the health reason, but also for an evaluation of your injuries and their development in the future. You may have been injured more seriously than you thought, and you may need medical assistance for a time. Who is going to pay for that? That's right, your compensation.

However, besides going to the doctor, you will have nothing more to do than make the occasional phone calls and trying to recover from your injuries. That's one of the best parts that working with an attorney can give you. Still, you have to be patient and let the lawyer do his job. His experience and background will probably be the best of your allies in this process. After all, he just wants to do his job right and win your case. When he considers himself prepared, a meeting is held in which a verbal agreement is reached and you win your traffic accident claim.
