

Find a Solicitor if you suffered an Accident and Claim Compensation

If you've been involved in a road accident that wasn't your fault, you are entitled to traffic accident compensation. For that, you need to file a claim to your insurance company in the case of a minor accident, or you should consider asking for a solicitor's services if the accident is more serious.

Traffic accidents are a common occurrence nowadays. They are hazardous and unpredictable events, which can happen even if you take all the necessary safety measures a traffic participant should take. Also, they can be traumatic events, both physically and mentally. They can deprive you from the good health you used to have or from the ability to go to work. That's why you need to be compensated.

The car accident basically has three forms: the rear-end accident, in which a car from behind smashes into the one in front of it; the side collision, usually encountered at intersections; head-on collisions, which are the most devastating, and happen when a driver wishes to pass the car in front and fails to notice the cars coming from the opposite direction or when the respective drivers misjudges the speed and the distance from the upcoming vehicles. The head-on collisions have the highest rate of deaths.

The motorcycle accident is most frequently encountered when a car driver doesn't notice the presence of the motorbike in dense traffic. The result is that the car driver crosses the motorcycle's path, thus provoking a collision. Motorcycle drivers, among all other vehicle drivers, are the most vulnerable to injuries, because they lack protection from the outside environment. Also, they are much more vulnerable to road flaws, such as holes in the road or spillages caused by bad road maintenance.

Pedestrians have something in common with the motorcycle riders, they are often not observed by vehicles present in the traffic. Of course, they are even more vulnerable than the motorcycle drivers, and seem to have the tendency of putting the blame for the accident upon themselves, even if it isn't the case.

It doesn't really matter in which category you are, if you've been involved in an accident caused by another person's negligence, you are eligible for traffic accident compensation. The first thing you need to do is call an attorney. Don't be scared at the prospect of a lawsuit, because it won't have to go that far. If the evidence is clear, the case will probably be solved as soon as possible, as an agreement is being reached between you and the party which injured you.

The traffic accident specialists work on a no win no fee basis. In a no win no fee arrangement you won't have to pay the lawyer for representing you if he doesn't win the case. However, although it sounds good, it has a catch: if you, by any means, lose your case, you'll have to pay the opponent's costs. You will probably have to pay for his lawyer, his phone bills, etc.

If this prospect scares you, there's a solution. You can make an insurance, which is called after the event insurance. This will be explained in detail by your lawyer at the beginning of the case. However, make sure you have at least a little bit of financial comfort before going into a no win no fee arrangement even if you are 99% sure that you are going to win the case.

If you see the big picture, you'll realize that it's worth it. There's really no point in settling for that small compensation the insurance company will give you. You need proper compensation for all your injuries and property damages. The traffic accident specialists have very good negotiation skills. They will probably manage to get you compensated for phone bills, current and future medical expenses, even their commission can be paid by the opponent. You don't have to go through the ordeal of recovery without a financial support simply because someone else was negligent. You really didn't want to go through an accident, you didn't ask for it. But if it happens, you need support. That's what the traffic accident compensation is all about.
